# **Cookie Policy**



With this document, we inform you, as users of these websites, about the use of cookies, in particular how the data of users – natural persons who browse, read or write their data on the website **https://www.kovohaken.cz** – are used.

### 1. CONCEPT AND PURPOSE OF COOKIES AND COOKIES TAGS

Cookies are small text files that are used to store and receive identifiers and other information about computers and other devices from which the user accesses websites. Cookies make it possible to record information about the user's visit to the website, and thanks to their use, the next visit is easier and faster.

### Cookies primarily:

- serve for efficient navigation in the Internet environment and on websites for personalization, saving preferences and generally improving the user experience;
- make it possible to distinguish whether a particular user has already visited the website in the past or whether he is new visitors and help to record statistics about website users;
- help display advertising tailored to the interests of a specific user.

TAG is a generic name for code elements found on web pages. Most tags simply describes the content of the page, but some types of tags contain program elements or to the page embed dynamic content such as video or audio files. Some tags may collect data about website users even without the use of cookies.

Specific purposes for which cookies incl. tags we use, you can find below in the overview tables.



### 2. TYPES OF COOKIES

From a general point of view, cookies can be divided based on several criteria:

### 2.1 Depending on who creates and processes cookies:

- first-party cookies ("first party cookies") that create websites or scripts directly on same domain.
   Most often, it serves to ensure the basic functionality of the website;
- third party cookies ("third party cookies") are created by other websites. These websites on visited the website owns some content, e.g. advertisements, images or videos.

### 2.2 According to their durability:

- session cookies are temporary. They are stored on the device only until the user finishes working with the web browser and are deleted after closing it. These cookies are necessary for the proper functionality of websites or associated applications.
- permanent cookies ("persistent cookies") are used for easier and more convenient navigation on websites (for example easier and faster navigation). These cookies remain in the browser for a longer period of time or until they are manually removed. The length of this period can depend on the selected web browser setting.

### 2.3 According to the purpose:

- necessary ("essential") cookies that are necessary for website operation. They include for example, cookies that allow the user to log in to secure parts of the website. These cookies do not collect information about users that could be used for marketing purposes or to remember which pages users have visited on the Internet.
- functional cookies facilitate control and improve website functions. They are used for activation
  specific site functions (e.g. video playback) and their settings according to the user's choices (e.g.
  language). Functional cookies are also used to remember your preferences the next time you visit the
  site. However, they do not collect information that could identify the user.
- performance/statistical ("analytical") cookies are used to improve the functioning of the website
  pages. These cookies collect information about how visitors to these websites they use, e.g. which
  pages visitors go to most often and whether they receive from websites error messages. Performance
  cookies allow to record and count the number of visitors pages, which makes it possible to track how
  visitors use these websites. These cookies do not collect information that would enable personal
  identification of the user. The information collected using these cookies is aggregated and anonymous.
- targeted and advertising ("marketing") cookies are used to track preferences and for purposes sending advertising messages in accordance with these preferences.

### 4. CONSENT

### Consent and rejection of cookies

Consent to cookies (statistical/analytical, functional, marketing) incl. tags can be expressed through the cookie bar (banner) and/or through the web browser settings. In the web browser settings, you can reject cookies or set the use of only some of them. However, if you use your browser settings to turn off all cookies (including essential cookies), you may not be able to access some parts of the website.

Most web browsers accept cookies by default. However, the user can change your browser settings and reject and delete cookies. The specific procedure is in the individual browsers differ, you can find more information in the help of your browser.
